At Spark Academy, we believe every tutor plays a vital role in creating a safe, supportive, and inspiring learning environment. This policy outlines the standards of conduct expected from all tutors to ensure the highest quality educational experience and the safety and wellbeing of every student.

Our Core Values

Compassion

Always put the child's wellbeing first. Be patient, kind, and supportive.

Integrity

Be dependable, honest, and punctual. Follow through on commitments and communicate clearly.

Excellence

Deliver high-quality, engaging, and well-prepared lessons tailored to each student's needs.

Inclusivity

Respect every learner. Make learning accessible and positive for children of all backgrounds, identities, and abilities.

Collaboration

Work closely with families and Spark Academy staff to ensure the best outcomes for students.

1. Professional Conduct

1.1 Appropriate Communication

- Always speak respectfully to students, families, and colleagues.
- Avoid slang, sarcasm, inappropriate humour, or sensitive personal topics.
- Use professional and age-appropriate language at all times.
- Maintain calm and constructive communication, even in challenging situations.

1.2 Professional Appearance

- Present a neat, clean, and professional appearance.
- For online sessions, ensure appropriate attire and a suitable background environment.
- Avoid clothing or visuals that may be distracting or inappropriate.

1.3 Reliability and Accountability

- Arrive on time and be fully prepared for all sessions.
- Provide reasonable notice for cancellations or schedule changes.
- Complete agreed administrative tasks promptly (e.g., session notes, reports).

2. Professional Boundaries & Relationships

Maintaining clear professional boundaries is essential.

- Tutors must maintain a professional relationship with students at all times.
 - Do not meet students outside agreed tutoring sessions unless authorised by Spark Academy.
 - Physical contact must always be appropriate and professional (where in-person tutoring applies).
- Tutors are role models and must always act in a way that protects both themselves and their students.

3. Safeguarding & Student Wellbeing

- Student safety and wellbeing is always the highest priority.
- All tutors must follow Spark Academy safeguarding procedures.
- Any concerns about a student's welfare must be reported immediately to the designated safeguarding lead.
- Maintain strict confidentiality of student information.
- Never promise a student to keep safeguarding concerns secret.

4. Use of Social Media

To protect both tutors and students:

- Do not add or accept students (or parents of current students) as friends or followers on personal social media accounts.
- Do not communicate with students via personal social media platforms.
- Do not post photos, videos, or identifying information about students.
- Ensure personal social media content reflects professional standards and does not bring Spark Academy into disrepute.
- Tutors representing Spark Academy online must act professionally and align with academy values. All student communication must occur through approved Spark Academy communication channels.

5. Mobile Phone & Device Use

During In-Person Sessions:

- Personal mobile phones must be on silent.
- Phones should not be used during sessions except for educational purposes.
- Avoid texting, browsing, or taking personal calls during teaching time.
- Do not photograph students without parental consent.

During Online Sessions:

- Use only approved platforms for tutoring.
- Ensure devices are secure and password protected.
- Conduct sessions in a private, appropriate setting.
- Do not record sessions unless authorised by Spark Academy and with parental consent. Professional device use protects student privacy and maintains session quality.

6. Online Tutoring Standards

When delivering virtual sessions:

- Log in on time and ensure all technology is working beforehand.
- Use neutral and appropriate virtual backgrounds if needed.
- Maintain professional behaviour just as in face-to-face teaching.
- Ensure communication remains transparent and, where appropriate, visible to parents or guardians.

7. Inclusivity & Equal Respect

Spark Academy is committed to equality and diversity.

Tutors must:

- Treat every student with dignity and fairness.
 - Challenge discrimination or bullying.
 - Adapt teaching to suit different learning needs.
 - Respect cultural, religious, and family values.
- Discriminatory language or behaviour will not be tolerated.

8. Confidentiality & Data Protection

Keep all student records secure.

- Do not share personal or academic information without proper authorisation.
- Dispose of notes securely when no longer needed.
- Follow all applicable data protection regulations.

- Termination of engagement with Spark Academy
